

ORDINANCE NO. 03-14

BOROUGH OF MOUNT EPHRAIM, NEW JERSEY

ORDINANCE OF THE BOROUGH OF MOUNT EPHRAIM, COUNTY OF CAMDEN,
AND STATE OF NEW JERSEY, AMENDING ARTICLES VII and VIII OF
CHAPTER 94 OF THE CODE OF THE BOROUGH OF MOUNT EPHRAIM
ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, parking during snow emergencies is currently prohibited on the side of any street in the Borough of Mount Ephraim on which the even-numbered houses are located pursuant to Section 94-15(A) of the Code of the Borough of Mount Ephraim (hereinafter "Code"); and

WHEREAS, the Board of Commissioners have deemed it in the best interest of the public health, safety and welfare to amend Section 94-15 as found Article VII of Chapter 94 of the Code to permit parking during snow emergencies on the side of any street on which the even-numbered houses are located on even years and on the side of any street on which the odd-numbered houses are located on odd years; and

WHEREAS, it has been determined that the penalties provided for in Article VIII of the Code need to be updated;

NOW THEREFORE, be it Ordained by the Board of Commissioners of the Borough of Mount Ephraim, County of Camden, State of New Jersey, as follows:

SECTION 1: Article VII - Emergency No Parking of Chapter 94 of the Code of the Borough of Mount Ephraim is hereby amended, revised and supplemented as follows:

§ 94-15. No Parking in Certain Areas During Snow Emergencies.

A. Whenever snow has fallen and the accumulation is such that it covers the street or highway, no vehicle shall be parked on the side of any street on which the even-numbered houses are located during odd-numbered years and no vehicle shall be parked on the side of any street on which the odd-numbered houses are located during even-numbered years.

B. [NO CHANGE].

SECTION 2: Article VIII - Penalties of Chapter 94 of the Code of the Borough of Mount Ephraim is hereby amended, revised and supplemented as follows:

§ 94-19. Violations and penalties.

Unless another penalty is expressly provided for elsewhere in this Chapter or under New Jersey statute, every person convicted of a violation of a provision of Chapter 94 of the Code of the Borough Mount Ephraim, or any supplement thereto, shall be subject to a fine of not more than \$50.00, or imprisonment for a term not exceeding 15 days, or both.

SECTION 3: Except as set forth in Sections 1 and 2 above, the balance of Chapter 94 shall not be affected by this Ordinance.

SECTION 4: All Ordinances, or parts of Ordinances, inconsistent herewith are hereby repealed to the extent of such inconsistency.

SECTION 5: If the provisions of any section, subsection, paragraph, subdivision, or clause of this Ordinance shall be judged invalid by a court of competent jurisdiction, such order of judgment shall not affect or invalidate the remainder of any section, subsection, paragraph, subdivision, or clause of this Ordinance.

SECTION 6: This Ordinance shall take effect immediately upon final passage and publication in accordance with law.
